All that certain tract or parcel of land situated in Lampasas county, Texas being 12.00 acres of land out of the A. M. Nelson Survey, A-1122 and being a part of that 82.795 acre tract severed from a 169.57 acre tract described in Deed to Leonard J. Karasek and wife Margie L. Karasek per Vol 275, page 981, Lampasas County Deed Records, said 12.00 acre tract described by metes and bounds as follows:

BEGINNING at a steel pipe for a corner post being in the East line of U. S. Highway 281 the NWC of said 82.795 acre tract and the NWC of this;

THENCE N74-03-43E (All GPS Bearings) along a wire fence, at 1034.43 feet a steel pin found at the base of a corner post, the NEC of this;

THENCE S22-46-44E along the fenced West line of the adjoining Joe Green ranch, at 528.35 feet a steel pin set, the SEC of this;

THENCE S78.44-37W, an unfenced line, at 1161.12 feet a steel pin set, the SWC of this;

THENCE N08-03-39W. along the fenced East line of said Highway, at 433.95 feet the Point of Beginning and containing 12.00 acres of land.

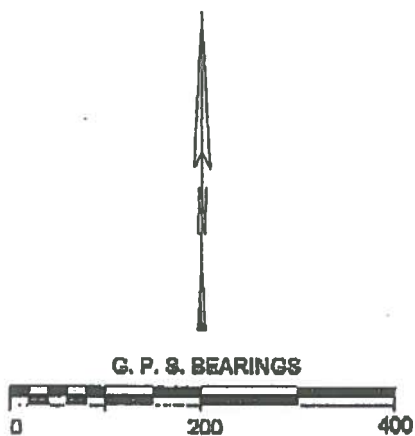
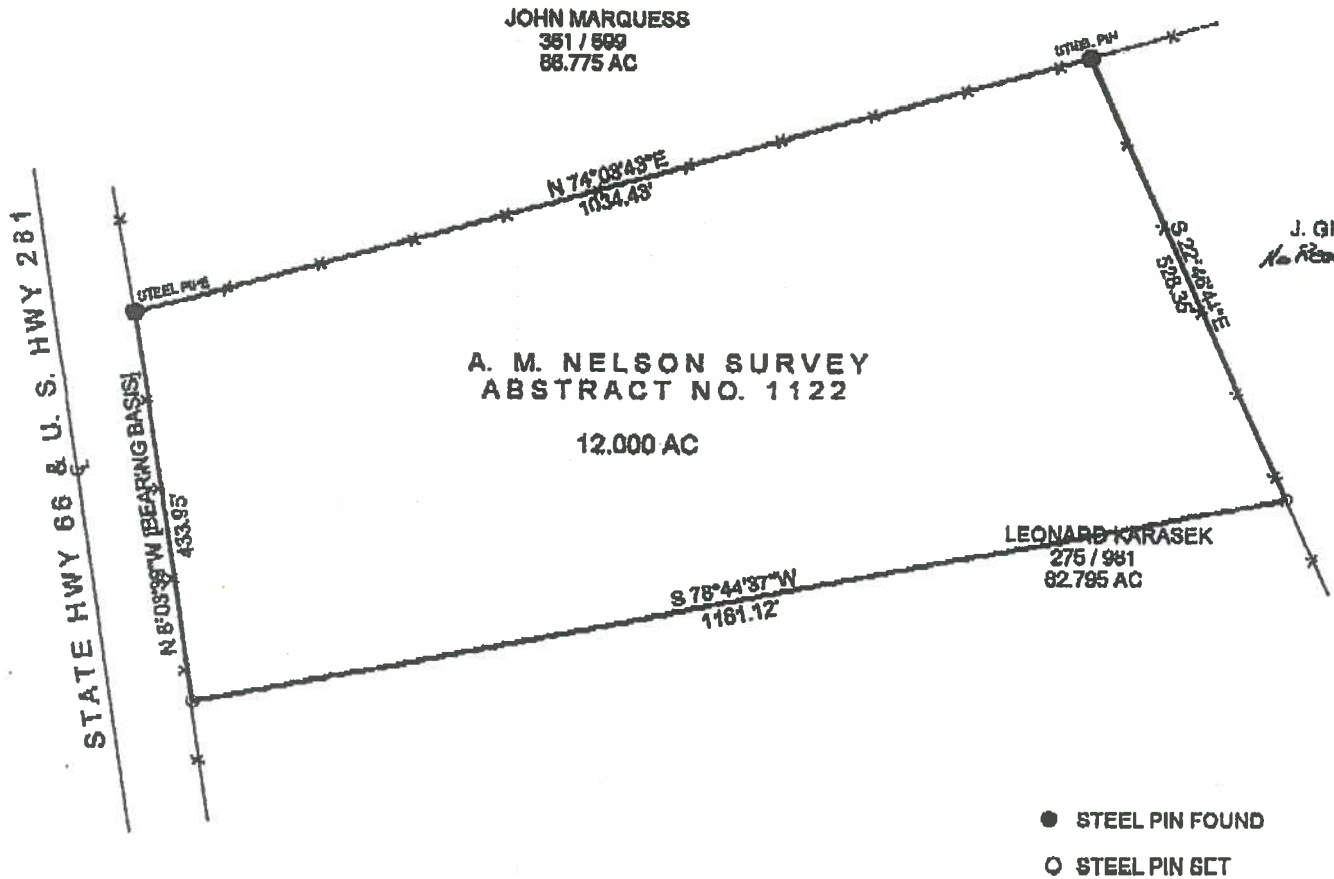
