HAMILTON COUNTY

All that certain tract, or parcel of land situated in Hamilton County, Texas and being 135.231 acres of land with 129.801 acres out of the B.C. May Survey, A-1064, 2.96 acres out of the B.C. May Survey, A-610, and 2.47 acres out of the Laura Burleson Survey, A-37, and described by metes and bounds as a result of this survey as follows:

BEGINNING at a steel pin set at the base of a 6 inch cedar post, the SWC of the T.J. Tone Survey, A-829, the NWC of the B.C. May Survey, A-1064, and the NWC of this:

THENCE S18-46W along a wire fence being generally common with the May West line, at 141.3 feet a steel pin found being the occupied NEC of the Richard Brown Survey, A-67, at 1111.2 feet a steel pin found, an exterior corner of this:

THENCE S00-48E, 80.0 feet and S51-54W, 89.0 feet crossing a branch, with steel pins set at the corners;

THENCE S19-10W along a wire fence being generally common with the said May/Brown Survey line, at 1070 feet the calculated SWC of the said May Survey, A-1064 also being the NWC of the B.C. May Survey, A-610, at 1189.8 feet a steel pin found in the West line of a county road, at 1419.4 a steel pin set at the base of a 6 inch cedar corner post, the SWC of this:

THENCE S12-00E crossing said county road, at 79.0 feet a steel pin set at the base of a 6 inch cedar corner post, an exterior corner of this:

THENCE S70-46E along a wire fence, at 29.0 feet a steel pin set in the West line of F.M. Hwy. 2842, an exterior corner of this;

THENCE along the arc of a curve to the right with curve data as follows: R=1005 feet, L=1127.15 feet, and chord=N76-51E, 1069.0 feet.

THENCE S71-01E along said North R.O.W. 431.8 feet to a steel pin set at the base of a 6 inch post, an exterior corner of this:

THENCE along the arc of a circular curve to the left, at 1510 feet crossing into the Laura Burleson Survey. Curve data is as follows: R=1382.5 feet, L=1969.54 feet and Long chord=N68-10E, 1807.08 feet.

THENCE N27-21E along the West line of said Hwy, at 1017.8 feet a steel pipe for a corner post being the calculated SEC of the T. J. Tone Survey and the NEC of this;

THENCE N 71-11W along the South line of the Tone Survey 2900.8 feet,
the place of BEGINNING and containing 135.231 acres of land.

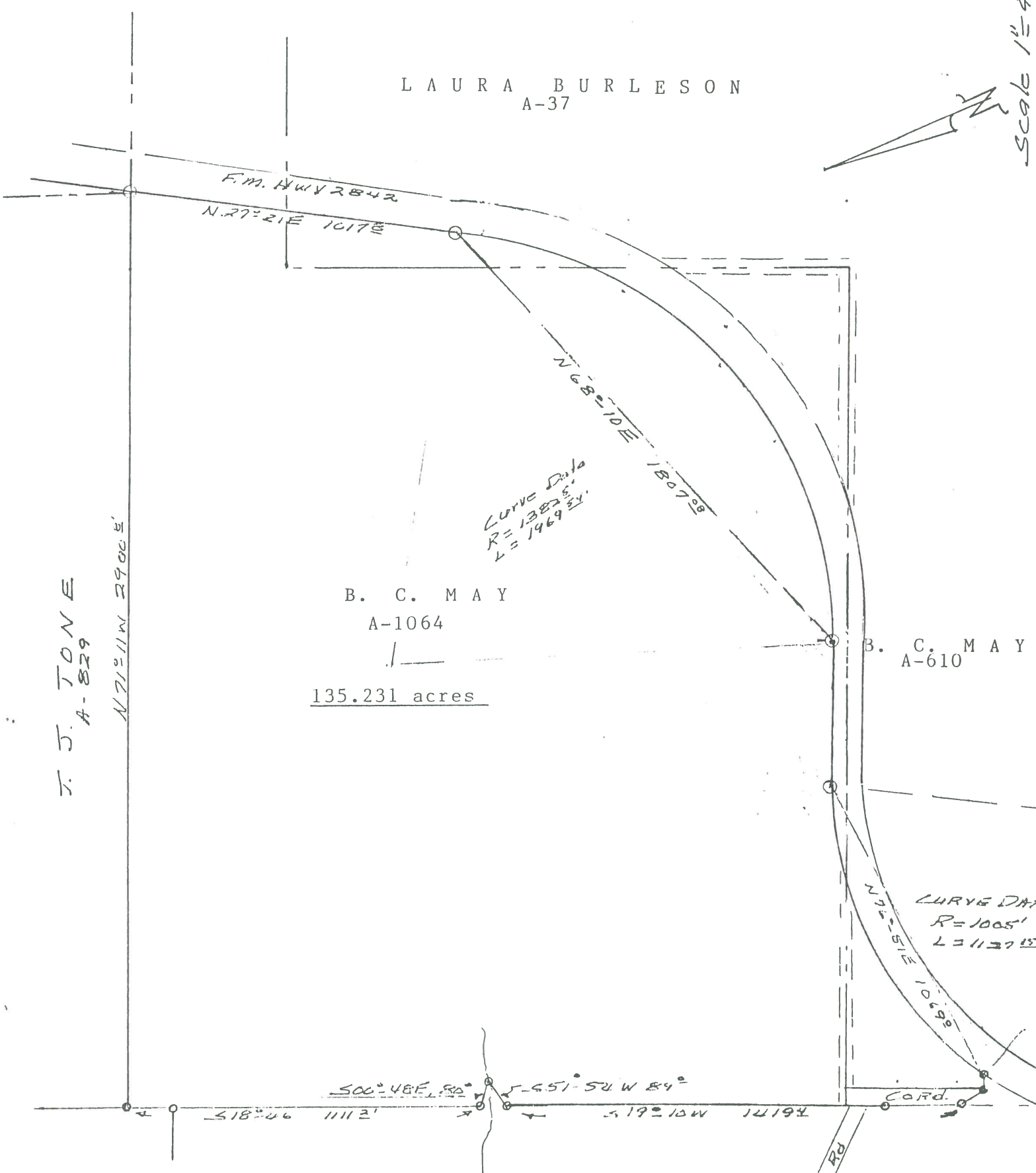
