

BEING a 24.437 acre tract of land situated in the C. J. O. LOCKHART SURVEY, ABSTRACT No. 640, Coryell County, Texas and being a part or portion of that certain 73.311 acre tract of land described in a Assumption Warranty Deed dated July 1, 1994 from Aubrey W. Wheat and wife, Allie L. Wheat to Terry L. Wheat and wife, Pamela J. Wheat and being of record in Document No. 78778, Official Public Records of Coryell County, Texas and being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2" iron rod with cap stamped "RPLS 2475" set being in the west boundary line of the said 73.311 acre tract which bears N. 17° 39' 40" E., 1085.93 feet from a 3/8" iron rod found at the southwest corner of the said 73.311 acre tract and being in the east right-of-way line of County Road No. 182 for corner;

THENCE N. 17° 39' 40" E., 543.22 feet with the west boundary line of the said 73.311 acre tract (calls N. 17° 39' 40" E., 1629.14 feet) and with the said east right-of-way line to a 3/8" iron rod found being the northwest corner of the said 73.311 acre tract and being the southwest corner of that certain 131.36 acre tract of land described in a General Warranty Deed dated December 3, 1997 from James C. Caddel and wife, Phyllis D. Caddel to Darrell G. Cadell and being of record in Document No. 110861, Official Public Records of Coryell County, Texas for corner;

THENCE departing the said east right-of-way line and with the north boundary line of the said 73.311 acre tract and with the south boundary line of the said 131.36 acre tract the following two (2) calls:

- 1) S. 72° 38' 37" E., 1779.93 feet (calls S. 72° 38' 37" E., 1779.93 feet) to a 1/2" iron rod found for corner;
- 2) S. 73° 12' 58" E., 160.95 feet (calls S. 73° 12' 58" E., 160.95 feet) to a 3/8" iron rod with cap stamped "4327" found being the northeast corner of the said 73.311 acre tract and being the northwest corner of that certain 201.798 acre tract of land described in a Deed dated July 20, 2021 from Douglas Flach, as Trustee of the McGinty Ranch Trust to Peggy McGinty McGuigan, Trustee of the McGinty Family Trust and being of record in Document No. 340969, Official Public Records of Coryell County, Texas for corner;

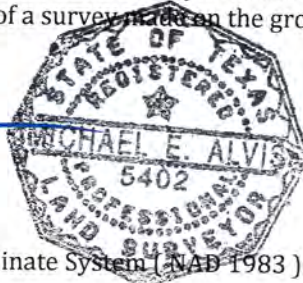
THENCE S. 17° 39' 25" W., 555.15 feet departing the said 131.36 acre tract and with the east boundary line of the said 73.311 acre tract (calls S. 17° 39' 25" W., 1662.92 feet) and with the west boundary line of the said 201.798 acre tract to a 1/2" iron rod with cap stamped "RPLS 2475" set for corner;

THENCE N. 72° 20' 20" W., 1940.88 feet departing the said east boundary line and the said 201.798 acre tract and over and across the said 73.311 acre tract to the Point of BEGINNING and containing 24.437 acres of land.
